- Classic and Card token devices can be collected from the Bank.
- If you have more than one account at MIB, write one of your account numbers. All of your accounts will be linked to your *FaisaNet* user.
- Your Daily Limit is the maximum transaction(s) amount (MVR or USD) you can do daily.

 - Make sure you login to the correct *FaisaNet* website, advisably, by always typing the address, faisanet.mib.com.mv, in your web browser.
 - Never disclose your Username or Password to anyone and change your Password periodically.

If you get any suspicious pop-ups or emails, or suspect any fraudulent activity on your accounts, report them to us immediately on 3011100 or at faisanet@mib.com.mv. You can also report them on *FaisaNet*.
 - Always keep your anti-virus software up-to-date with the latest virus signatures.
