



Terms & Conditions

MIB Trivia

Eligibility

This campaign is open to all Maldivian citizens and valid work permit holders residing in the Maldives. Employees of Maldives Islamic Bank (MIB) are not eligible to participate.

Format

- The MIB Trivia Quiz will be conducted at the MIB stall during the Maldives Food Carnival.
- The quiz will be held on 17 July 2026 and 18 July 2026 during the event.
- Each participant is permitted to participate only once throughout the campaign period.
- Participants are permitted to participate only once throughout the campaign period.
- Participants who correctly answer 3/5 quiz questions will be eligible to receive one (1) FaisaWear Ring.

Entry Criteria

- Participants must complete the quiz at the MIB stall.
- Participants may be required to provide their full name and National ID number (or Work Permit number, where applicable) for verification and prize collection purposes.
- Incomplete, inaccurate, or invalid entries will not be considered eligible.

Prizes

- FaisaWear Rings will be awarded during the campaign.
- Eligible winners will receive one (1) Faisawear Ring.
- Winners may choose their preferred ring size from the sizes available at the MIB stall, subject to stock availability.
- Ring sizes and colours will be allocated on a first-come, first-served basis while stocks last.

Prize Eligibility

- Participants who correctly answer 3/5 quiz questions and meet all eligibility requirements will receive a FaisaWear Ring until the daily allocation of rings is exhausted.
- Once the daily allocation has been fully distributed, no further prizes will be awarded on that day.
- The decision of Maldives Islamic Bank (MIB) regarding participant eligibility and prize allocation shall be final and binding.

Prize Collection

- Winners must collect their Faisawear Ring from the MIB stall during the Maldives Food Carnival.
- Winners may try on sample rings to determine the appropriate ring size, subject to availability.
- Upon selection of the ring size, MIB staff will assist with the activation of the FaisaWear Ring.
- The prize is non-transferable, non-exchangeable, and cannot be redeemed for cash or any other product.

General Conditions

- MIB reserves the right to verify the eligibility of all participants.
- MIB reserves the right to disqualify any participant who provides false, misleading, or incomplete information or who attempts to manipulate the quiz process.
- Personal information collected during the campaign will be used solely for participant verification, prize administration, and campaign-related purposes.
